

2020 Census Overview



Why is the Census Important for the Jefferson Area?

The Constitution requires a count of everyone living in the United States, regardless of age, immigration status, language spoken, etc. The goal is to count everyone once, only once, and in the right place. However, conducting an accurate count has proved challenging: the 2010 Census missed an estimated 1.5 million people nationwide, including 21% of people in Allegheny County – enumerators had to complete extra follow up with these individuals to ensure they were counted.

The Jefferson Area constitutes nearly 20% of Allegheny County’s population, so our area is impactful. Historically, some communities have been more likely to be missed in the count:

- Children (specifically ages 0-5)
- Immigrants
- People of Color
- Rural Households
- Low-Income Households
- Students at Local Colleges & Universities

Changes to the 2020 Census Increase Difficulty for an Accurate Count in the Jefferson Area

- **Digital Divide:** The Census Questionnaire will be moving online for the first time, which could pose issues for older adults.
 - 19% of Jefferson Area Adult Population is over 65
- **Decreased Funding:** Less resources available to fund outreach efforts
 - Number of local Census Bureau centers cut in half
- **Complexity:** Confusion around changes to this Census may affect participation (i.e. pending litigation on citizenship question, digital divide, etc.)
 - 40% of Allegheny County’s refugee population reside in the Jefferson area

How Does the 2020 Census Impact Us?

Pennsylvania is particularly vulnerable – if an undercount occurs, PA is ranked second nationally in:

- the amount of dollars that could be lost per person missed, and
- total federal funds that would be lost per year.
