

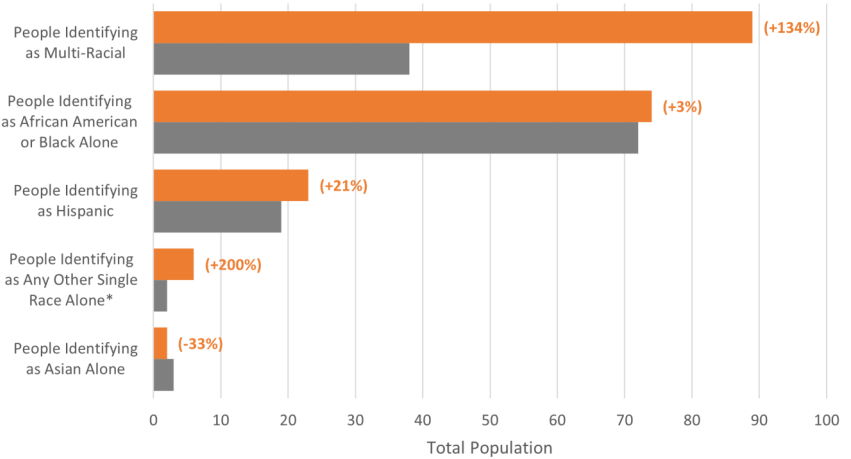
Community

Population: 1,398

- The Elizabeth Borough **total population decreased by 6%** from 1,493 in 2010.¹
- The Elizabeth Borough population **represents about 1% of the total Jefferson area population.**
- Similar to the Jefferson region as a whole, the **borough is experiencing changing racial demographics.** The White Alone population decreased by about 11% from 1,359 in 2010 to 1,204 in 2020, but still remains the area's largest racial group, comprising about 86% of residents.¹
- **The population identifying as Any Other Single Race Alone tripled** and the Multiracial population grew by 134% between 2010 and 2020, reflecting trends in the Jefferson area.¹
- The **median age in Elizabeth Borough is 39**, younger than Allegheny County (41) and older than the City of Pittsburgh (33). Of the total population, 18% are under 18 years, 66% are ages 18-64, and 16% are 65 or and older.

Changing Diversity in Elizabeth Borough Change in Selected Racial & Ethnic Demographic Populations 2010 to 2020

The population of people who identify as White was 1,359 in 2010 and 1,204 in 2020 for a decrease of 11.4%. The White population is not included in the chart below to maintain readability.



*Due to small sample size, we have included individuals identifying as Native Hawaiian and Other Pacific Islander, American Indian, or as an identity not listed in the survey ("Other") in *People Identifying as Any Other Single Race Alone*. Note that racial categories are non-Hispanic.

666 Individuals receiving income supports from DHS³

Services may include Supplemental Nutrition Assistance Program (SNAP), Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF), Medicaid or receive health insurance through HealthChoices. Data is for 2022.

224 Individuals received transportation assistance through ACCESS⁵

ACCESS is a door-to-door, advance reservation, shared-ride transportation program provided throughout Allegheny County. Data is from 7/1/2021 through 6/30/2021.

210 Households received utility assistance from LIHEAP⁴

The Low Income Home Energy Assistance Program (LIHEAP) helps families living on low incomes pay their heating bills. Data is from 10/18/2021 through 6/17/2022.

27 Homelessness & housing services have been provided by the DHS³

Services are provided by DHS and DHS-contracted providers and include housing assistance, case management, prevention and outreach for individuals and families receiving prevention services, support services and/or housing who are homeless or at risk of becoming homeless. Data is for 2022.

<Less than 6> Individuals receiving Partner 4 Work services⁵

Title I (WIOA & WIOA Dislocated Workers) includes services that focus on finding jobs and providing more in-depth services such as training programs for adults and dislocated workers. Participants are assigned a case manager and work with that manager to secure an employment position. Data is from 7/1/2021 through 6/30/2021.
