

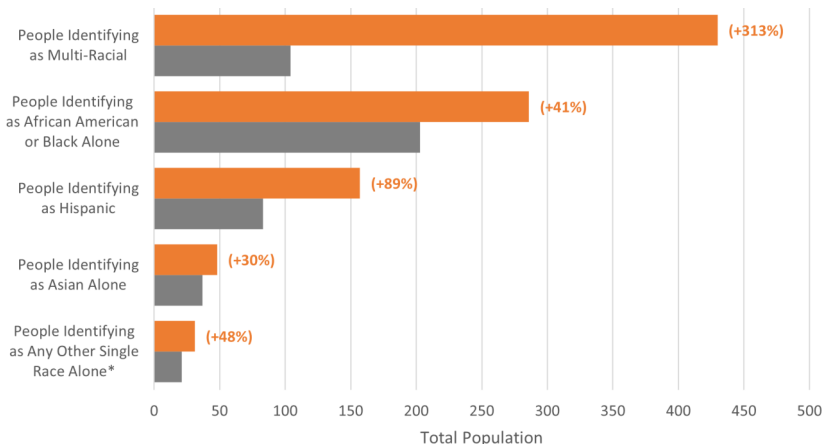
Community

Population: 12,982

- The Elizabeth Township **total population decreased by 2%** from 13,271 in 2010.¹
- The Elizabeth Township population represents **about 6% of the total Jefferson area population.**
- Similar to the Jefferson region as a whole, **the township is experiencing changing racial demographics.** The White Alone population decreased by about 6% from 12,823 in 2010 to 12,030 in 2020, but still remains the area's largest racial group, comprising about 93% of residents.¹
- **The Multiracial population grew by 313%** and the Hispanic population grew by 89% between 2010 and 2020, reflecting trends in the Jefferson area.¹
- The **median age in Elizabeth Township is 49**, older than Allegheny County (41) and the City of Pittsburgh (33). Of the total population, 17% are under 18 years, 60% are ages 18-64, and 23% are 65 or and older.

Increasing Diversity in Elizabeth Township Growth in Selected Racial & Ethnic Demographic Populations 2010 to 2020

The population of people who identify as White was 12,823 in 2010 and 12,030 in 2020 for a decrease of 6.2%. The White population is not included in the chart below to maintain readability.



*Due to small sample size, we have included individuals identifying as Native Hawaiian and Other Pacific Islander, American Indian, or as an identity not listed in the survey ("Other") in *People Identifying as Any Other Single Race Alone*. Note that racial categories are non-Hispanic.

Services Provided in Elizabeth Township

2,895 Individuals receiving income supports from DHS³

Services may include Supplemental Nutrition Assistance Program (SNAP), Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF), Medicaid or receive health insurance through HealthChoices. Data is for 2022.

372 Individuals received transportation assistance through ACCESS⁶

ACCESS is a door-to-door, advance reservation, shared-ride transportation program provided throughout Allegheny County. Data is from 7/1/2021 through 6/30/2021.

293 Households received utility assistance from LIHEAP⁴

The Low Income Home Energy Assistance Program (LIHEAP) helps families living on low incomes pay their heating bills. Data is from 10/18/2021 through 6/17/2022.

103 Homelessness & housing services have been provided by the DHS³

Services are provided by DHS and DHS-contracted providers and include housing assistance, case management, prevention and outreach for individuals and families receiving prevention services, support services and/or housing who are homeless or at risk of becoming homeless. Data is for 2022.

Title I (WIOA & WIOA Dislocated Workers) includes services that focus on finding jobs and providing more in-depth services such as training programs for adults and dislocated workers. Participants are assigned a case manager and work with that manager to secure an employment position. Data is from 7/1/2021 through 6/30/2021.
