


Increasing Diversity in West Homestead Borough Growth in Selected Racial & Ethnic Demographic Populations 2010 to 2020

The population of people who identify as White was 1,612 in 2010 and 1,474 in 2020 for a decrease of 8.6%. The White population is not included in the chart below to maintain readability.



The West Homestead Borough total population decreased by

- experiencing changing racial demographics. The White Alone population decreased by about 9% from 1,612 in 2010 to 1,474 in 2020, but still remains the area's largest racial group, comprising about 79% of residents.¹
- The population identifying as Any Other Single Race Alone* grew by 450% and the Hispanic population grew by 165% between 2010 and 2020, reflecting trends in the Jefferson area.1
- The median age for West Homestead Borough is 42, about the same as the Allegheny County (41) and older than the City of Pittsburgh (33). Of the total population, 18% are under 18 years, 61% are ages 18-64, and 21% are 65 or and older.



*Due to small sample size, we have included individuals identifying as Native Hawaiian and Other Pacific Islander, American Indian, or as an identity not listed in the survey ("Other") in *People Identifying as Any Other Single Race Alone*. Note that racial categories are non-Hispanic.

Public Transportation

All JRF: 7% Allegheny County: 9% City of Pittsburgh: 17%

- 9% of population age 16 and over take public transportation to work.
- 76% of workers drive alone with avg. commute time of 30 min.

Median Household Income

All JRF: \$57,879 Allegheny County: \$62,320 City of Pittsburgh: \$50,536

- On average, 18% of families have income below 200% of the federal poverty level (FPL).
- 36% of families under 100% of the FPL are single mother families.

College Education

All JRF: 30% Allegheny County: 43% City of Pittsburgh: 45%

- 34% of population 25 years old and over has completed a Bachelor's Degree or higher.
- This represents an increase from 2015 estimates (26%).

Labor Force

- 65% of residents age 16 and over are in the labor force.
- The labor force for the borough is 57% female, 43% male.

- 74% of occupied housing units are owner occupied and 26% are renter occupied.
- 91% of housing units are occupied.

653 Individuals received transportation assistance through ACCESS⁶


