

Changing Diversity in the MASD Change in Selected Racial & Ethnic Demographic Populations

2010 to 2020

The population of people who identify as White was 22,834 in 2010 and 18,578 in 2020 for a decrease of 18.6%. The White population is not included in the chart below to maintain readability.



*Due to small sample size, we have included individuals identifying as Native Hawaiian and Other Pacific Islander, American Indian, or as an identity not listed in the survey ("Other") in *People Identifying as Any Other Single Race Alone*. Note that racial categories are non-Hispanic.

The McKeesport Are School District (MASD) total population decreased by 8% from 31,254 in 2010.1

The MASD population represents about 13.5% of the total Jefferson area population and comprises the City of McKeesport, and neighboring municipalities of Versailles, South Versailles, Dravosburg, and White Oak.

- The school district is experiencing changing racial demographics. The White Alone population decreased by 19% from 22,834 in 2010 to 18,578 in 2020, along with the Asian Alone population (by 30%).1
- The population identifying as Any Other Single Race Alone* and the Hispanic population grew by 79% and 49%, respectively, between 2010 and 2020, reflecting trends in the Jefferson area.1
- The median age for the MASD community is 47, older than Allegheny County (41) and the City of Pittsburgh (33). Of the total population, 20% are under 18 years, 57% are ages 18-64, and 23% are 65 or and older.

- On average, 41% of MASD families have income below 200% of the federal poverty level (FPL).
- 73% of families under 100% of the FPL are single mother families.

College Education

All JRF: 30% Allegheny County: 43% City of Pittsburgh: 45%

- 16% of population 25 years old and over has completed a Bachelor's Degree or higher.
- This represents a slight increase from 2015 estimates (16%).

Graduation Rate⁷

All JRF: 92% City of Pittsburgh: 82%

- As of 2020, MASD had 3,186 number of total students enrolled with 30% receiving special education services.
- MASD has 4 public schools.

Owner-Occupied Housing

All JRF: 71% Allegheny County: 64% City of Pittsburgh: 47%

- 53% of occupied housing units are owner occupied and 47% are renter occupied.
- 86% of housing units are occupied.
